The conference fun begins on Friday with a Golf Tournament at the resort starting at 12:30 pm. Registered attendees are welcome to attend the opening reception and buffet dinner that evening.

The conference will continue on Saturday morning, April 30th at 8:00 am with a Professional Development (PD) program for all attendees (Officers & Enlisted). Units of the AZ Army and Air NG have been given a specific number of slots for military members who will be able to attend the PD program on a paid status; if you're interested, contact your Unit First Sergeant or Commander.

EANGA SUPPORTS ARIZONA BILLS

The Arizona Legislature is back in session and the docket is full of new bills. EANGA is supporting five House bills and one Senate bill. The basics of these bills are described in the following paragraphs.

HB 2033, Post-9/11 Veteran Education Relief Fund- The post-9/11 veteran education relief fund is established consisting of private donations, grants, bequests and any other monies. A qualifying military veteran may apply for financial assistance for the cost of tuition at a university that is under the jurisdiction of the Arizona Board of Regents and that is an Arizona veteran supportive campus. The assistance shall be based on financial need up to the amount of tuition that the qualifying military veteran was charged in the last year that the veteran received benefits under the post-9/11 veterans educational assistance act of 2008. Additional requirements to qualify for this assistance is explained further in the bill itself. EANGA is supporting this bill because many Arizona National Guard members qualify for this and it may assist them in the completion of a college degree. Currently, this bill passed in the House, completed the first reading in the Senate on February 16th, and is scheduled in the Public Safety, Military, and Technology Committee on February 24th.

HB 2105, Veterans with Disabilities; Benefits- A veteran of the armed forces of the United States who has been a resident of this state for one year or more and is at least 25% disabled from service connected disabilities can receive a complimentary license, a vehicle license tax exemption, a free park pass that grants park entrance to all Arizona state parks along with a waiver of camping and overnight parking fees for up to ten days per month. EANGA supported this bill, because we support our veterans; unfortunately, this bill failed in the House Military and Public Safety Committee.

HB 2153, VLT Exemption; Military Members; Spouses- Beginning January 1, 2017, the registering officer may not collect a vehicle license tax or registration fee for a vehicle owned by a surviving spouse or a surviving dependent of a deceased member of the United States military who was killed in the line of duty or who died from injuries suffered in the line of duty. EANGA is supporting this bill, because we support our military members and their families, who have endured hardships and need assistance in different ways. This is one way to help. Currently, this bill has been transmitted to the Senate and is waiting to be heard in the Transportation Committee.

HB 2194, Women Veteran Special Plates- This bill is an amendment to clarify the requirements to qualify for this special plate. The Department of Veterans' Services shall pay thirty-two thousand dol-

lars from the veterans' donations fund established to the department of transportation for implementation of this section. The department of transportation shall issue women veteran special plates to a person who submits satisfactory proof to the department that the person is a veteran and to the immediate family member of a person who has been issued a license plate pursuant to this section. EANGA supports this bill, because we want to ensure that the Women Veteran Special Plates continue to be available for our women veterans. Currently, this bill is waiting to complete the first reading in the House.

HB 2229, Community Colleges; Tuition Waivers- The district board shall waive the first two years of tuition and fees for students who reside in this state and who maintain a grade point average of at least 2.5 on a 4.0 scale, or the equivalent, for the duration of the two-year tuition waiver period. EANGA supports this bill, because tuition waivers at community colleges could help an Arizona National Guard member to complete their associate's degree for transfer to a university and it could assist airmen who are required to complete their CCAF associates degree to be promoted to E-8. Currently, this bill is waiting to be heard in the House Government and Higher Education Committee.

HB 2329 Appropriation; Veterans Services; Veterans Home is the House version of SB 1114. It is worded exactly the same way and EANGA will support this version. HB 2329 has passed the Military Affairs and Public Safety Committee, and is currently waiting to be heard in the House Appropriations Committee.

SB 1114, Appropriation; Veterans' Services; Veterans' Home - The sum of \$10,000,000 is appropriated from the state general fund in fiscal year 2016-2017 to the department of veterans' services for distribution to the city of Flagstaff for construction of a veterans' home in Flagstaff. EANGA supports this bill, because there is no veterans' home in Flagstaff and we support our veterans. Currently, this bill is scheduled to be heard in the Senate Appropriations Committee on February 23rd.

EANGUS LEGISLATIVE WORKSHOP

Over 150 EANGUS members from across the nation attended the annual Legislative Workshop held at the National Guard Memorial Building, Washington, DC from 6-9 February 2016. In addition to updates on EANGUS legislative activities and policy discussions, the attendees heard from enlisted representatives of the NGB Legislative Liaison Office, as well as CMSgt Mitchell Brush, SEA to the Chief NGB; CSM Brunk Conley, CSM of the Army NG; and CSM Luther Thomas, CSM of the US Army Reserve. As part of the workshop, attendees also scheduled appointments with their elected Congressional or Senate members or their staffers to discuss EANGUS Point Papers and other issues of concern to National Guard members. Attendees from AZ included MSG Bernardo Acosta, EANGA President; CMSgt-Ret Dean Miller, EANGA Legislative Chair, and CSM-Ret Karen Craig, EANGA Membership Chair /EANGUS Secretary. Of the eleven

elected AZ officials serving on Capitol Hill, our EANGA members were able to meet personally with seven members, and also met with staffers from the other four offices. Additionally, EANGUS asked our AZ members to participate in a special award ceremony on the evening of February 9th and the EANGUS G.V. Sonny Montgomery Eagle Award was presented to Senator John McCain. EANGUS selected Senator McCain as well as Congressman Joe Heck from Nevada to receive these prestigious awards for their work on the blended military retirement proposals included in the FY16 National Defense Authorization Act.



IT'S SCHOLARSHIP TIME!

The Arizona Enlisted Association is pleased to announce our annual scholarship program which is just one of the many benefits of your membership in the Enlisted Association of the National Guard of the United States (EANGUS). Our scholarship program is open to AZ National Guard enlisted personnel and their spouse or dependent children who are or will be attending college in the fall of 2016.



The 2016 Scholarship program includes:

a. The Enlisted Association of the National Guard of the United States offers the CSM Virgil R. Williams Memorial Scholarship which generally awards at least two, but up to ten - \$2,000 scholarships annually. This is the National Scholarship Program and winners will be announced during the EANGUS Conference in New Orleans, LA, in August 2016.

b. The Enlisted Association National Guard of Arizona will offer two scholarship in 2016. The CMSGT Gerald R. Guild Memorial Scholarship will provide one - \$1,500 scholarship. Additionally, through our Arizona association, USAA has funded and is offering one - \$1,000 scholarship this year. This scholarship is titled the Harry & Mary Hensell Scholarship. Both of these Arizona scholarships will be awarded and presented during an appropriate ceremony after 1 May 2016.

The Enlisted Association of the National Guard of the United States "Auxiliary" also sponsors an annual scholarship program. Details concerning eligibility and applications for the Auxiliary scholarship program are available at: <http://eangusauxiliary.org/scholarships-2/>. The scholarship recipients will be announced during the EANGUS National Conference in August.

We encourage participation in these scholarship programs and request your assistance in sharing, posting, or publishing the availability of these scholarships to eligible AZNG enlisted personnel and their dependents. Eligibility criteria and requirements to apply are described on our website or can be provided by mail, upon request.

The deadline for submission of applications for the National and State programs listed above is 16 April 2016. INTERESTED IN SERVING ON THE EANGA BOARD?

The Arizona Enlisted Association is currently seeking current Association members (Active, Retired, or Life) who are interested in running for office. Elections will be held during the business session of our Annual State Conference on Saturday, April 30, 2016. The following information is provided regarding the positions that are up for election; the term of office for each position is two (2) years, unless indicated otherwise.

President: Must be an AZ Army or Air NG member (active, former, or retired); must be a current (paid) Association member in good standing for at least six months prior to nomination; must have attended at least two meetings within the last 12 months prior to the election. This is a one year term to fulfill the balance President Bernardo Acosta's term; MSG Acosta is resigning from this position due to his current service as the EANGUS Area VI Director and member of the EANGUS Executive Council.

Vice-President Air: Must be an Air NG member (active, former, or retired); must be a current (paid) Association member in good standing for at least six months prior to nomination; must have attended at least one meeting in the last 6 months.

Vice-President Junior Enlisted: Must be an Army or Air NG member in the rank of E6 or below; must be a current (paid) Association member in good standing for at least six months prior to nomination; must have attended at least one meeting in the last 6 months.

Secretary: Must be a current (paid) Association member (active, former, or retired) in good standing for at least six months prior to nomination.

Director Army: Must be an Army NG member (active, former, or retired); must be a current (paid) Association member.

Director-At-Large: Must be an Army or Air NG member (active, former, or retired); must be a current (paid) Association member.

Conference Delegates: Must be either an Army or Air NG member (active, former, or retired); must be a current (paid) Association member, and must attend at least one meeting prior to the National Conference. Must will willing and available to attend the EANGUS National Conference in New Orleans, LA from 21-24 August 2016.

As you can see, there are minimal requirements to be eligible to run for office, and even if you haven't attended an EANGA Board meeting in the last 6 months, our next meetings are scheduled for Thursday, 17 March and 21 April, both meeting are held at 1730 hrs. If interested in attending a meeting, contact President Acosta at bernardo.m.acosta@gmail.com for the location or dial-in conferencing information. All enlisted personnel are always invited and encouraged to attend our board meetings.

If you meet the minimal requirements described above, are interested in serving your fellow enlisted Soldiers and Airmen thru participation on our EANGA Executive Board, and have time to devote (generally this involves monthly meetings - many can be attended by audio conference calls).....we encourage you to submit your nomination! TRICARE REFORM CONSIDERATIONS

As the Senate and House Armed Services Committees begin consideration of the National Defense Authorization Act, more and more information about potential changes to military health care are being released.

During the Senate Guard Caucus Breakfast on Tuesday, February 23, Senate Guard Caucus Co-Chair, Senator Lindsey Graham (R-SC) addressed the possibility of a pilot program for National Guard members wanting coverage beyond what is offered under TRICARE Reserve Select (TRS). The pilot program would give members of the Guard and their family members access to the Federal Employee Health Benefit Plan (FEHBP) which is managed by the Office of Personnel Management (OPM). The health care plans offered under FEHBP will likely be a more expensive alternative than TRS.

If the Senate creates a pilot program to expand health care coverage options - by allowing EANGUS members access to FEHBP - the EANGUS National Office staff will suggest that TRS be an option available to members under the FEHBP pilot. Therefore, if anyone is not wanting to change health care plans, that individual can remain on TRS.

The Senate Armed Services Committee (SASC) hosted a health care reform hearing on Tuesday, February 23, and the SASC Military Personnel Subcommittee will host a posture hearing on Tuesday, March 8 at 2:30 PM ET; both of these can be viewed on CSPAN. Scott Bousum, the EANGUS Legislative Director has been invited to testify during the hearing. EANGUS will keep an eye on this issue and provide more information on the hearing at a later date.



EANGUS now uses VoterVoice as our grassroots advocacy tool. Be on the lookout for EANGUS Legislative Calls to Action and use VoterVoice to connect with your elected officials on Capitol Hill. So that you can track Guard-specific legislation and EANGUS activities at any time, download the VoterVoice phone app on your mobile device by going to your App Store.
